HIGHLIGHTS FROM BOARD MEETING CONDUCTED ON JANUARY 31, 2023: President Palfrey reviewed the following highlights from the Board meeting held on January 31, 2023.

- Today's Speaker: Ann Bonner, Experience with Hurricanes while living in Florida, introduced by Becky Schambow.

Ann is the Supervisor of Cardiopulmonary & Sleep Lab Services at Southwest Health where she's been employed for 19 years.

Prior to moving to Platteville Ann lived and worked in West Palm Beach and then Port St. Lucie as the Director of Respiratory Care at Lawnwood Medical Center. Lawnwood is a large acute care facility that has 378 beds. It was the hurricanes of 2004 and less than optimal schools for her kids that brought her to Platteville to live near her father, Lester Goke and her late mother Sylvia.

Ann noted that waters warming feeds hurricanes, and although hurricanes can be predicted people aren't always prepared. She added humor by prefacing that hurricanes always used to be named with female names, because they are "her- i -canes". Now the names are alternated alphabetically between male and female names. Names are never re-used.

Ann spoke primarily about her experience with Hurricane Frances, which was a category 4 hurricane that occurred in August of 2004. The hospital she worked for was built to sustain 200 mph winds and a category 5 storm. She spoke of many challenges they had with power and equipment failures, but stated the biggest lesson they learned was that hospitals can't be used as sheltering facilities as they must ensure they are able to do their primary job which is to take care of patients.

Dan grew up on a dairy farm in North Dakota and after high school, he attended Valley City State University. He later went on to receive his masters in Management from the University of St. Scholastica in Duluth, Minnesota.

Dan provided a wealth of information about the growth in providers and services at Southwest Health. He noted that when he arrived at the organization twelve years ago, Southwest Health had two paid providers (i.e. doctors and mid-levels) and now employs 63 medical staff providers. The organization has grown from 245 employees to 565.

Dan noted that recently two new surgeons have joined the Orthopedics Department. Dr. D. Opel specializes in hand surgery and Dr. J. Prosser specializes in sports injuries. He noted that several other new providers are coming on board throughout the next several months.

Recently, Southwest has built and opened new clinics in Cuba City and Kieler and have purchased 12 acres of land in Darlington to add another clinic location.

Dan spoke about Southwest's purchase of 12 acres north of the hospital acquired for business development. The land was developed in collaboration with the City. He noted that the property is ready for building businesses, but Southwest wants to ensure they would be "medical like".

Southwest is working with UW-Platteville, Southwest Technical College, and Platteville Public Schools for possible child care facility to be built on the acquired land. They have received a Federal Appropriations grant, however, further grant funding is needed to bring this to fruition.

It was evident that Dan is very proud of the team of providers and staff who work at Southwest and the services that they are able to provide to our communities.

- Today's Speaker Brian Lenzmeier, CRNA, ARNP, APNP Pain Management Provider at Southwest Health – introduced by Becky Schambow

Brian Lenzmeier provides Pain Management services at Southwest Health. His educational background started by obtaining a BS in Nursing from Seattle University. He then obtained his Master's degree in Nursing at the University of TX in Houston, and a Master's degree of Science in Administration at Central Michigan University. He completed his Fellowship in Advanced Pain Management at Hamline University in St. Paul, MN.

Major Lenzmeier retired from the Army in 2009 after more than 14 years of service. While in the service he provided care to patients at Walter Reed Army Medical Center, and after completing his anesthesia training was quickly deployed to Iraq and later served in the Joint Special Operations Command throughout the Middle East using his skillset on the frontlines in the harshest of conditions.

Brian stated that "Interventional Pain Management is basically putting a needle where it hurts". He noted that comprehensive pain management often involves other health specialties like physical therapy, orthopedic care, chiropractic services, etc.

His area of practice frequently attempts to localize the nerves causing the pain, putting local anesthesia and then steroid injections on those affected nerves. In some cases, patients don't respond to the injections and may need an ablation procedure, which is a procedure that prevents pain signals from being sent back to the patient's brain.

Appointments for Pain Management must come from primary providers, and authorization for treatment is obtained from patient's insurance companies prior to procedures being done.
