BOARD OF DIRECTORS MEETING REPORT: Highlights of the June 3, 2024 Governing Board meeting were presented by President Reeves.

TREASURER'S REPORT: D. Borgen provided the Treasurer's Report for period ending May 31, 2024, which included information on the Internal and Youth Account balances.

- Grant(s) Paid in May included:
 - Platteville Special Olympics \$300;
 - WI Leadership Seminar \$250.
- Approval: President Reeves reported the Board has made a motion to approve the Treasurer's report. Seconded by Dan Engelke, motion carried.

COMMITTEE REPORTS: President Reeves provided summaries of Committee reports.

Finance Committee:

- **Dues Report:** D. Borgen reported to the Board that two members have yet to pay their dues. Charlie Clark, Co-Chair of Membership Committee has sent reminder emails to these members. If they have not paid by July 1st they will be officially removed from membership.
- Acquisition of Club Credit Card: The Board discussed feasibility of obtaining a credit card for
 use by the Club. Currently our website and Zoom membership costs are billed/paid through the
 Club Secretary's credit card. There was some feeling that having a business credit card may be
 helpful to those buying supplies for our events, etc. No decisions were made at this time. Further
 investigation will include checking with the website and Zoom companies to see if they would
 accept payment via EFT (electronic fund transfer).
- Donation/Pledge to Fire Department Building Fund Campaign: It was reported that a
 donation/pledge form to "Inspiring Community" for our \$5000 pledge for the Fire Department
 building fund (\$500 paid and \$4500 pledged to be paid over the next four years) will be completed
 and submitted by President Reeves.

Community Service:

- **Golf Outing Report:** President Reeves thanked those who volunteered and provided cookies/bars for the Golf outing. The event raised over \$5000 for support of the Grant County Sheriff's Department initiatives.
- Party in the Park July 25: President Reeves reported that Ernie Thalmann and Community Service Committee members are planning for the event. The Club will serve hotdogs and cookies. Ernie added that the Club will be ordering fewer hot dogs this year due to the fact that last year other food vendors were there so there was a decrease in hotdogs needed. Ernie noted that cookies will be given away instead of ice cream due to a vendor issue.

• Weekly Meeting Notes via Email: President Reeves noted a member has volunteered to take weekly meeting notes and send them out to members via email on a weekly basis. President Reeves added that the Board discussed this offer relative to weekly verses monthly "Highlights" and redundancy issues. Jerry Schewe then advised the members that he was the person who volunteered to do the weekly notes in an effort to send information to members in a more-timely manner. Becky Schambow added that she will be resigning as Secretary as of September 30, 2024 and hopes that whatever decision is made does not require the upcoming Secretary to take notes at weekly meetings if Jerry does. Becky noted that our Club Secretary is only required, according to Bylaws, to take minutes of Board and Business meetings and taking weekly meeting notes is time consuming. Becky wants to ensure there is not a duplication of efforts in reporting going forward. President Reeves noted that the Board recommended the topic be discussed with Jerry by the Publicity/Newsletter/Website committee.

- Next Week's Speaker June 21st: Dawn Drake, Ruby's Pantry & Fellowship Dinners Platteville Optimist Club Highlights June 2024

 Today's Speakers: Jill Goffinet and Alyssa Shanahan from the Senior Center, recruited by Chris & Paul Budden, and introduced by Chris.

Chris began by saying that Jill and Ally have taken the Senior Center to new heights since making the move to City Hall in July 2023. The Center is seeing new faces daily and continuously introducing new programs to keep seniors in the Platteville area interested.

Jill started working at the Senior Center more than 15 years ago and Ally started in 2021 and these two work together like two peas in a pod. As the Program Coordinator, Jill organizes daily programing and tends to day-to-day operations. Ally is the Center Manager, and takes care of administrative work and marketing. In their positions, the ladies oversee the Platteville Commission on Aging and Platteville Area Senior Support, the fundraising arm of the Senior Center. They do all this and so much more as part time city employees, shoulders to lean on, and "cattle wranglers".

Ally began the presentation by talking about their new location at City Hall that had renovation costs of over \$50,000. This new location has: hearing assistive capabilities; a 75" TV; a craft room; an exercise room; game area; activity center that holds 45 people; and more storage than in prior location. Ally noted their appreciation to the City for finding and designating parking for those attending the Senior Center.

Jill, a Platteville "home town girl", stated she has always cared about senior citizens, and feels that her position is a way of giving back to the community. Ally added that she feels like she and Jill are family members to the seniors. She noted that they are even having a special wedding reception with the seniors in honor of Alliy's wedding which was upcoming the following week.

They noted games that seniors participate in include: Bridge; Cribbage; Hand and Foot Dice; Left-Right-Center; Bingo; and Euchre. Annually they have a "Skunk Party' at which time anyone who hasn't scored in a card game over the prior year can participate. Humorously, prizes include air fresheners.

They also coordinate with Warco Bus Service and take day trips about three times per year, which include a lot of trips to theatres, etc.

The Center has a large group who come to fitness class, which they now hold at the Masonic Temple for added space.

In August there are plans for a "Seniors' Picnic", of which approximately 200 people usually attend at the Evangelical Free Church.

December plans include their annual party, of which they received a \$4500 grant from United Way to offset costs.

Ally explained that they continually seek grants, and hold brat sales, etc. This is done by PASS (*Platteville Area Senior Support*), which as noted above is the fund raising arm for the Center.

In conclusion, Tim Murphy acknowledged from his experience with the Center, that both Jill and Ally are very dedicated and do a tremendous job.

 - Need for Vice President and Club Secretary: Our meeting Facilitator noted that our Club needs to have a Vice President and Secretary named for the 24-25 Fiscal Year. Any member interested in these positions were encouraged to contact President Reeves or Vice President Hundhausen.
 - Make Music Platteville: Terri Ellis encouraged members to attend the "Make Music Platteville" events occurring on this date in various locations in Platteville.
- Next Week's Speaker on June 28th: Barb Stockhausen on Rotary Club's Foreign Exchange Program
- Today's Speakers: Dawn Drake was recruited by Chris & Paul Budden and was sharing information on community services including: Ruby's Pantry; Food and Fellowship; and Crafting and Quilting for Christ.

Dawn Drake retired from UW-Platteville after working 33 years in the UW System. She earned a bachelor's degree in business from UW-Platteville, an MBA from UW-Whitewater, and has all but completed her dissertation in distance and continuing education from UW-Madison. Drake was central in developing the university's first online programs. She oversaw distance and continuing education at UW-Platteville from 1999 until her retirement in 2018. Her career has included university teaching, advising, recruitment, administration, and quality coordinator. Drake has written numerous articles and made conference presentations in the areas of distance education, leadership,

and human resources. She also wrote and received many grants throughout the years. She has been involved with business consulting throughout her career and continues with this in a part-time capacity in retirement.

Dawn began her presentation by explaining that she was going to talk about programs that are sponsored through the United Methodist Church, but that the events are "community events". The first program she talked about was "Ruby's Pantry", which occurs in the church parking lot on the first Thursday of every month and is coordinated/served by volunteers. "Ruby's Pantry" is headquartered in Minnesota and its founder started the service in memory of his mother. The food provided is all donated from corporations. The motto for the program is, "This is for anyone who eats". On the day of the event, a semi arrives with approximately 23,000 pounds of food made up of about 20-23 food items. Dawn noted there is always a protein product, but otherwise there is a wide variety of foods. The food is unloaded, and divided into approximately 400 shares. The people served are asked to pay \$25 of which \$23 helps pay for the transport of the food and \$2 is put into a scholarship fund, used to help those who can't afford the \$25. For that \$25, those served receive an estimated \$150 in groceries. It takes approximately 100 volunteers to help on Ruby's Pantry days and additional volunteers are always welcome.

The second program Dawn talked about was "Food and Fellowship". This program was started with a grant in March of 2020 and functions on grants and co-sponsorships. This program occurs on the 2nd Wednesday of every month where they serve between 275-450 people from 5 to 6 p.m.

Dawn talked about their "Quilting and Crafting for Christ" program which is also grant funded. Volunteers make lap quilts for all ages, in addition to making cards and other crafts. The volunteers meet on Tuesday from 3-6 p.m. They coordinate with Family Advocates, Southwest Cap, police and EMT's, social services agencies, etc. who can give the items to comfort those in need.

In conclusion, Dawn invited anyone interested to visit and enjoy the church's "Community Memorial Garden" and "Labyrinth".

 the Rotary Club and were recruited by Chris and Paul Budden. Paul provided their introduction with
 information about their histories with Rotary.

Barb Stockhausen is starting her second year as the President of the Rotary Club of Southwest Wisconsin/Platteville. She was a member of Platteville's original Rotary club until it dissolved and is a Charter Member of the current club which celebrated its 10 year anniversary this year. Barb has also been an Optimist member for more than 25 years. Barb is recently retired after owning and operating an H&R Block franchise for more than 30 years. She has served as an Alder on the Platteville City Council and has served on the Southwest Tech District Board, H&R Block National Franchise Council and Wisconsin Public Radio Association Board. She is currently a member of the Southwest Tech Foundation Board and very active in Girl Scouts, becoming a lifetime Girl Scout in 1994.

Angie Wright is a Charter Member of the Rotary Club of Southwest Wisconsin/Platteville and has served as the Treasurer since 2016. Angie started her relationship with Rotary back in 1988 when she was a senior in high school and participated in the Rotary Youth Exchange program and spent a year in Brazil. Angie works as a freelance grant professional helping nonprofit organizations and municipalities secure funding to implement projects and reach their goals. She is on the board of the PHS Scholarship Fund, Inspiring Community Inc., and volunteers with the Rountree Gallery. In her free time Angie enjoys riding her bike on the rural roads of Southwest Wisconsin, baking crusty sourdough bread, knitting, and spending time with her family.

Barb opened by thanking the Optimists for inviting them to speak about Rotary's student exchange program, but gave the floor to Angie to talk about her experience and close hand knowledge about the program.

Angie began her presentation by distributing pictures taken when she was a Rotary 17 year old foreign exchange student in Brazil. She noted that Rotary is a "global network" with over 46,000 clubs across

the world. Countries sending students out via the exchange program receive the same number of students from other countries.

Rotary Clubs' Mission is to "provide service to others, promote integrity, and advance world understanding, goodwill, and peace".

Addressing Rotary's "Long Term" exchange program, Angie noted students are sent to their host countries for a period of 11 months. The students are typically hosted by two or three different families during that period of time. Families treat the students like they would their own family. For this experience, students only pay for their personal items with Rotary picking up travel costs, etc. Rotary also provides them with a \$75/month allowance and pays for their cell phone.

Platteville's Rotary Club has had 5 outbound students who have gone to France, Japan, Spain and Hungry. Platteville has hosted three students coming from Thailand, Columbia, Brazil, and will have another this fall from Denmark. Rotary attempts to place students in countries where the student speaks the language. In Angie's case, she was sent to Brazil and can speak both Portuguese and Spanish.
