WEEKLY MEETING – APRIL 12, 2024

- Today's Speaker: Paul Budden Platteville Fire Department's Capital Campaign

Tom Nall recruited and introduced our Club Member, Paul Budden, who today was speaking to members about the Fire Department's plans for a new building and the Capital Campaign for same.

Tom noted that Paul worked in construction was then was employed by the City of Platteville in the streets department for 18 years. Paul's passion and dedication to the Fire Department extends over an almost thirty-year history with the department. He has been a truck captain, an assistant chief, and the department's training officer. He was a lead instructor for the "Citizens' Academy Program" and a Fire Instructor at Southwest Technical College.

Paul began his presentation by stating "I hate fund raising", but because of his passion he is committed to the Capital Campaign.

He reported the current fire facility, which is sixty years old, was assessed for its ability to meet the needs of the Fire Department, both in providing a safe working environment for the firefighters and providing service to the public. The study found that the current facility has inadequate turnout and decontamination spaces for firefighters as well as a lack of storage space for gear, equipment and trucks.

Not having adequate space required for an expanded facility, it was determined that the current location was not sufficient for expansion. After evaluating options, it was determined the new facility would be constructed on the decommissioned O. E. Gray Elementary School. The new facility will not only provide for expanded space for fire department needs, but will have seven dorm rooms for sleeping in the event the City would go to a paid department. In addition, those dorm rooms could be used for police officers or snow plow operators who live in other communities, but have to stay in town in times of severe weather. Other features that the new facility will provide will include a decontamination unit with a filtering and a safe drainage system enabling the department to extract smoke/chemicals from turn out gear. The facility will have a "training tower" that will be used to train firefighters in: confined space entry; ladder practice; search and rescue; physical fitness; and be used for drying out hoses.

The new fire station has an estimated cost of \$14.5 million, of which \$7 million is to be covered by a federal grant. An additional \$6 million will be provided through the budgets of the fire district partners of 7 townships and the City of Platteville. The remaining \$1.5 million must be generated through donations and grants.

Those members wanting to tour the current facility were invited to meet Paul at the building following the meeting.

- Today's Speakers: Darlene Masters and Melissa Palfrey were today's speakers, providing information about the history and services of Family Advocates.

Family Advocates originated a little over 40 years ago. With use of a power point, they showed pictures of the old convent on Court Street that the agency had used since 1989. That facility only had 5 to 7 bedrooms, with little space for training, kitchen needs, etc.

Family Advocates operates by acquisitions of grants and donations and they received an American Rescue Plan Act grant in the amount of \$3.5 million to enable building of their new building. There is also additional acreage adjacent to the building which will have solar panels. Darlene and Melissa both are involved with applying for/acquisition of grant funding and donations.

The new facility is manned 24 hours per day and provides shelter to victims of domestic abuse for both female and males. Pets of those families are also allowed. The victims' initial stay can be 45 days during which time they are expected to seek employment and housing. The 45 days can be extended to 90 days with an application for extension, but the agency must see that they are applying for jobs and working towards independence.

In addition to providing housing, the agency provides outreach programs as well to assist victims. This even includes volunteers that help children with academics.

The staff consists of 8 day and 4 night staff members, in addition to some volunteers. Their training consists of: on-line programs; hands on training in the facility; and State agency training programs. Staff members are also cross-trained and the agency provides internships.

Members then split into groups and were provided a tour of the new facility.

Conclusion: The tour was concluded about 8:10 a.m.
